The same may perhaps be conducted after the training of State Coordinator. • The Director of Kripa Foundation informed the members that the Ministry of Social Justice and Empowerment alongwith AIIMs will be randomly selecting the villages for sample survey. In this regard, Director of Social Welfare stressed the need to select the places where vulnerable sections are concentrated for evolving a clear picture on the extent of Drug Abuse. In this connection, the matter will be apprised to the Higher Authority by the Project Implementing Agency (Kripa). The Director Kripa and his Team expressed his deep appreciation towards Shri. H.M. Shangpliang, I.A.S. for his prompt action towards the noble cause, which is highly motivating.

Lastly, vote of thanks to all members was extended by Shri. H.M. Shangpliang, I.A.S. Chairman of State Level Committee on National Survey on the extent and pattern of Substance (Drugs) Abuse.
